Widened operating system support	The new Server Pool Monitoring Agent is compatible with Sun Solaris 10 and Linux distributions based on 2.6 kernel.

Server Pool Monitoring Agent v4.0.0 supports the following operating systems and versions:

- Microsoft[®] Windows[®] 2000, 2003, and XP (U.S. English) *
- Red Hat Enterprise Linux 4 and 5, Fedora 6 and 7 **
- Sun[™] Solaris[™] 8, 9 and 10 (SPARC)
- *) Only the U.S. English version has been tested, but other locales may work as well.
- **) Also other Linux distributions may work, but are not tested.

Build Version

Server Pool Monitoring Agent v4.0.0 build version is 402.

Compatibility

Server Pool Monitoring Agent v4.0.0 is recommended to be used with the following StoneGate component versions:

- StoneGate Management Center v4.0.0 or later
- StoneGate Firewall/VPN v3.0.8

Installation Instructions

The main installation steps for Server Pool Monitoring Agent v4.0.0 are as follows:

- 1. Copy the installation package to a Server Pool member on which you wish to have the Monitoring Agent installed.
- 2. Use the operating system specific installation method to install the Monitoring Agent.
- 3. Configure the Monitoring Agent by editing sgagent.local.conf and sgagent.conf files.

Detailed instructions for Server Pool Monitoring Agent installation and configuration are described in StoneGate Administrator's Guide.

Upgrade Instructions

To upgrade an earlier version of Server Pool Monitoring Agent to Monitoring Agent v4.0.0, backup the configuration files (sgagent.local.conf and sgagent.conf), uninstall the existing Monitoring Agent, and install the new Monitoring Agent as instructed above. After that, the old configuration files can be restored.
