# Features

## Audio Playback on Review Dashboard

Audio playback for voice events can be enabled on the Review Dashboard through configuration in the `ro-ui.env` file. Enabling this ability will change which transcript appears for voice events.

## Feature Highlighting on Voice Events

Highlighting from feature scoring is now visible in the transcript for voice events.

## Configurable Default Entity Timeline Slider Percentage

The Entity Timeline slider can be configured in the `ro-ui.env` file. The default value is set to 80%.

## Event Mode Tooltip on the Review Dashboard

The event mode is now displayed in a tooltip for events on the Review Dashboard, replicating the functionality previously available on the Explore Page.

## Prevent Asterisk Usage in RQL on Explore Page

To increase stability of searches performed from the Explore Page, FBA by default prevents the use of wildcard asterisk searches in the Advanced Search field on the Explore Page. This restriction can be disabled in the `ro-ui.env` file.

## Reduce Scrolling on Review Dashboard

Attachments will no longer be automatically expanded on the Review Dashboard to reduce the need for scrolling.

## Review Status Added to Entity Timeline

On the Entity Timeline, a column has been added to show the most recent review status of an event.
